Did you know the *Love to the Rescue* logo (the one with the heart-shaped ring) should only be used for fundraising purposes? Check to make sure you are using our philanthopy's name properly when referring to Shriners Hospitals for Children and make sure you are using the up-to-date disability terminology. Beja Shriners Policy # 17 Social Media

This social media policy presents and explains the rules governing social media use by Beja Shriners, including those applying to the public relations committee and the membership in general. This social media policy exists to ensure all members use their social accounts in safe and effective fashions. Although social media can benefit Beja -- especially in terms of marketing, relationship building and recruitment -- poorly-judged or -timed activity can hurt our reputation.

1. Beja Shriner's social media policy pertains to all members.

For the purposes of this policy, social media may refer to:

- Popular social networks such as Twitter and Facebook
- Photo-sharing websites such as Pinterest and Instagram
- Professional social networks such as LinkedIn
- Discussion forums such as the ones found on 4chan and Reddit
- Question and answer-based networks such as Quora and Yahoo Answers

Review systems such as Yelp and Google Reviews

When Beja members are posting on their personal accounts, they may be known to be a Beja Shriner and therefore are encouraged to follow basic best practice rules.

- Think before posting. This is the golden social media rule. Beja has spent time and resources building its reputation and good will with its customers, the public. Before you make any post consider the effect on Beja's reputation or your reputation as a Shrine Mason.
- Correct your own mistakes. When you make a factual error in a post, create an update to correct it. Deleting or editing the original post should come at your own discretion, depending on the situation.
- Don't escalate issues. Responding to other social media users, especially concerning a contentious subject, can result in a heated argument. To avoid such arguments, it may be best to avoid commenting if you feel you may spark conflict.
- 2. Beja Shrine social media accounts must only be used and created by authorized individuals for the purpose of meeting the defined goals of Beja Shriners.
- As Beja Shriners must explore the advantages and disadvantages of expanding its social media presence into new networks, the Beja Public Relations chairman shall approve the creation of all new Beja-related social media accounts. This includes Club and Unit groups or pages.
- The Public Relations Chairman should be an 'Administrator' on all Beja-related groups and pages.
- 3. Whether the social media account is personal or under the Beja Shriners name, members should not:
- Bring discredit to Shriners nor should they fit within the definition of conduct unbecoming. Conduct contrary to the accepted and customary rule of right and duty between Shrine Masons or to society in general, is improper
- Distribute material that could be interpreted as libelous or defamatory
- Share updates, images and messages that may tarnish the public image of yourself, Beja Shriners, Shriners International, or, Shriners Hospitals for Children®
- Distribute spam and chain messages

News from Shriners Hospital Chicago

Shriners Hospitals for Children

Exciting things are happening at SHC-Chicago!

Terri Aiello has accepted the position of Director of Patient Care Services/Nurse Executive. Terri has been with SHC-Chicago for almost 43 years and has done an outstanding job in many roles including most recently as the Director of Performance Improvement.

Dr. Gabriela Martinez has joined SHC-Chicago as a Physiatrist. She will be partnering with Dr. Sue Mukherjee to help expand the Rehabilitation program. We are also recruiting a full time Pediatric Orthopaedic surgeon, as we continue to grow by providing pediatric orthopaedic services for two new hospital partners in the Chicago area.

SHC-Chicago is working with Novartis to develop a program for patients with Spinal Muscular Atrophy to receive Zolgensma, the latest gene therapy treatment. Additionally, we are working to develop a Skeletal Dysplasia clinic by partnering with BioMarin, which provides enzymatic replacement medications and genetic testing through their partner, Invitae.

SHC-Chicago recently hosted the "Second Annual State of Research Symposium: Special Emphasis on Muscle Bone Health". Physicians, clinicians, and researchers from across the Shriners system provided updates and discussion on current and future research projects to help improve the care of children with bone and joint conditions, disorders, and diseases with the goal of creating greater collaboration on multi-center research projects.

January saw 194 new patient exams and 217 new referrals scheduled. Our doctors also treated 23 stable fractures with three of those requiring surgical intervention. This is a direct result of the work of our physician liaisons who made over 1500 face-to-face visits with area health care providers during the preceding month.

Recently, SHC-Chicago received a note from a patient's grandaunt. I'd like to share it with you:

"I am Teresita Pacris, Eulysam's grandaunt. (If you recall the elderly lady tagging along during the weekly visits, that's me.) I'm more than happy to inform you that Eulysam is back in the Philippines. He's back at school and his mom, Chrystee, is back at work. I've been told by my sister (Eulysam's grandma) that Eulysam still cries whenever he is asked about his stay at Shriners. Pictures, the toys and little throw blankets he got from the cart every week - all make him cry. Thank you, thank you, thank you. We can't thank you enough for having been so patient and very accommodating every time we had an issue or every time we needed something. You were like Chrystee's "go-to person."

I'm very sorry I couldn't thank you in person before I flew back to New Orleans. Please extend my gratitude to Dr. Altiok, Dr. Gundeti, Dr. Mukherjee, Liz, Diana, Patti, and the nice ladies at Rehab - Kathleen, Debbie, and Alexia. Everyone was so nice that Eulysam didn't want to go home. He cried when he checked out after the inpatient rehab stint, and he cried again after his last PT session with Kathleen. On the whole, you all gave him a life-changing gift - the ability to walk. You all made him feel at home, though home was actually miles and miles away.

I hope that God will continue to bless you and your loved ones."





How Coronavirus COVID-19 Is Affecting Beja Shriners

Greetings Nobles and Ladies

I would like to take this opportunity to update all of you on the impact that the Coronavirus COVID-19 has had on Beja as a whole. Just before the Spring Ceremonial March 14th I made the difficult decision of cancelling our Breakfast with the Easter Bunny. We continued with the Spring Ceremonial knowing that attendance may be low but felt the health impact was also extremely low as well. On March 13th President Trump has declared National Emergency to combat COVID-19. As of now I have suspended all Beja Events which includes all Clubs and Units events. We are still waiting to see if the 2020 Imperial Session in Kansas City will still take place. I am hoping that we will be able to have our May or June meeting.

To help with meetings, Google online has a service called Google Meet and I offered to set up online meetings for Clubs and Units who wish to use this service, free of charge. You can use your phone or computer for this. With the high percentage of older members in our Temple, those seemingly being targeted by this virus, we must do our part to protect our own and others. I highly encouraged you to reach out to your fellow Nobles and Ladies, ensuring they are healthy and not in need. If you are worried about a fellow Noble or his family, please keep in contact with them by phone or text.

Having to cancel this years Circus will have serious financial impacts on Beja this year. The Circus is the main fundraiser for Beja, providing 70% of our operating budget. I worked with Gene Reece, PP to review and discuss opportunities with the Divan on how we may be able to reduce the impact this will have on our 2020 operating Budget. I will present my suggestion for reducing the impact of this years budget at the April Divan meeting. I would ask that all Clubs and Units consider this as you look into your gift giving at our November Parade to Glory meeting.

I want to urge all Nobles and their families to take precautions when traveling out of your own household. Remember that older people and people of all ages with severe underlying health conditions - like heart disease, lung disease and diabetes, for example seem to be at a higher risk of developing serious COVID-19 illness. Remember to regularly and thoroughly cleaning your hands with an alcohol-based hand rub or wash them with soap and water. Take precautions by maintaining at least 6 feet distance between yourself and others. Restrain from touching many surfaces which you can pick up Continued in the next cloumn

Shriners Healthcare for Children Twin Cities

Below are some of the highlights from your Shriners Hospitals for Children- Twin Cities for 2019. Should you have any questions, please feel free to contact me.

2019 HIGHLIGHTS: Several important achievements are noted below.

- Model Change Completed: The model change to a clinic was legay completed in December 2018. Subsequent wort refined the surgery process with Gillette Children's Specialty Healthcare. Final service changes were completed by March with closure of the laboratory.
- · Staffing was reduced from 56 FTEs at the start of the year to 51 FTEs by year-end 2019.
- 318 surgeries were completed at Gillette and 21 surgeries were performed at the University of Minnesota.
- A new name, Shriners Healthcare for Children—Twin Cities, was adopted and incorporated into digital, print and visible signage.
- Outreach: Agreements were reached with the following community partners to establish new outreach clinics in 2019.
- Boys Town National Research Hospital. Boys Town NE: This site started regular outreach clinics and telehealth services. The initial kick off event was held August 8th. A camp for kids, Camp Nebraska, was held in nearby Gretna, NE for TCC patients.
- Bone & Joint Clink, Bismarck ND: Outreach clinics are now offered every other month at this location.

Black Hills Orthopedic and Spine Center, Rapid City SD: A new schedule of every other month outreach was established at this site.

- Blank Children's Hospital, Des Moines IA: A partnership agreemant has been formulated to develop the pediatric orthopaedic services at Blank using TCC employed surgeons. Service is expected to begin late an 2020. A donor appreciation event was held in Des Moines concurrent with the wort at Blank Children's. This was the first experience with an out-of state donor event.
- **Donations**: \$3.6 million received in total donations exceeding the stretch goal of \$2M. A campaign to raise \$400,000 for the purchase of digital x-ray equipment was completed in 2019.
- Over 20 Camp and Event experiences were offered to TCC patients during 2019.

- Camp explore Nebraska: A new patient camp, was conducted outside Omaha, NE in June 2019. Over twenty campers (local area patients) participated.
- Give to the Max Day was held in November 2019. Received donations of almost \$97,000 in a single day for the Twin Cities Clinic.
- 4th Annual Gala: Celebratng 95 years of serving children, was held in June. Nearly 400 quests attended the event, netting over \$230,000 in support for the Twin Cities Clinic.
- Clinical Measures: TCC continued to meet clinical care benchmarks. Patient satisfaction was maintained well over the 90th percentile for all services against the compare gruop.

We have an exciting year ahead of us for 2020. Some quick highlights, the ribbon cutting for our new clinic will be on Saturday May 30th. We will begin full operations at the new site around July 1st. We will be hosting three outreach camps this year in Iowa, Nebraska and South Dakota as we continue to meet our mission of seeing more kids in more places for less. Cost.

Hello Everyone, The Building Task Force has come to a recommendation on how to proceed with keeping the members of the NEW Masonic Center at the Beja property. We came to our conclusion after many long hours of research and debate. I would like to commend the members of this task force on their dedication and level headedness. We all had specific groups we were representing but lets face it, we're all intertwined. Many thanks to Brad Ottum, Gary Fehl, Jake Sylvester, Jeff Andersen, Craig Laes, John VanLanen, Tom Pinney, Bob Dotson, Gene Reece, and Craig Cloutier. Yes, these are the men that should be thrown under the bus with me.

We did not take this job lightly; we looked at six different options:

- 1. An addition to the east side of Beja that would house the NEW Masonic Center members.
- 2. Remodel Unit Building #1 to house the NEW Masonic Center members along with a new storage building to house their "stuff".
- 3. A major remodel of the existing Beja building.
- 4. A cosmetic remodel of the existing Beja building.
- 5. Leave everything the same and hope the members of the NEW Masonic Center would accept that.
- 6. Have the NEW Masonic Center members move to a new location.

We considered the financial aspects along with projected membership numbers to draw our conclusion.

The Building Task Force recommendation is a cosmetic remodel in two phases. Phase 1 would remodel our cafeteria and main hallway with new flooring, paint and a folding wall for lodge meetings. Our electric sign would be reconfigured to include NEW Masonic Center members and a section of Unit Building #1 would be built out for NEW Masonic Center storage. Phase 1 may also include moving the Library and Museum into the existing conference room and Potentate's office. The Potentate would move into the Recorder's office and the Recorder would share Ann's office.

Phase Two, to be considered possibly next year, would either continue the cosmetic remodel into the office area or reconsider the major remodel option.
