She received her first prosthetic arm, her "helping hand," shortly after her first visit to the Twin Cities Shriners Hospital. By the age of 1, she

decided that she wanted to do everything with her "little arm" and stopped using her "helping hand." Now 19, Emily has spent her whole life feeling proud of her ability to do many things with her "little arm." From tying her own shoes, riding her bike, and crossing the monkey bars to becoming a strong swimmer and lifeguard, Emily has proven she has strength and a will to succeed.

Emily attended the Twin Cities Shriners Hospital's Camp Achieve from ages 5-13. Camp Achieve is a day camp for patients with limb differences. Participants spend a week trying new activities that they think they may not be able to accomplish due to missing a limb. One of the huge benefits of camp is giving kids exposure to other children who are "just like them," as they may not know anyone else with a limb difference from their community. Because Emily holds Camp Achieve so close to her heart, she volunteered as a helper at camp when she was older. She has been an excellent teacher and role model to children who are facing similar challenges due to missing a limb, just like she did as a child. Her passion for advocating for herself and others who are living with limb differences is inspiring.

Emily was the swim captain on her high school swim team and inspired her teammates with her ability to compete in all of the drills and strokes. She always served as a good example and mentor on her swim teams and as a lifeguard. Emily continues to use her swimming and lifeguarding skills at an annual biathlon in her hometown, where she proudly stands at the waterfront, ready to help her community members and friends as they swim.

Emily is currently enrolled at St. Cloud State University where she is studying occupational therapy. Her dream is to be an occupational therapist at Shriners Hospitals for Children.



### News from Shriners Hospital Twin Cities

# A Letter from the Chairman of the Board –SHC–Twin Cities

#### July 8, 2018

A few days ago, Imperial Sir Jerry Gantt, Chairman of the Board of Trustees, sent an email message to all the nobility in which he outlined discussions that had be occurring regarding four hospitals in our system, SHC-Twin Cities being one of them.

In his message he denoted plans for changes which had been developed over the last few months by workgroups from each hospital. These workgroups consisted of local hospital leadership, local board representation, home office personnel and lead by a consulting group hired for this purpose. This workgroups charge was to review the options available to us for delivering the best possible care to our kids and their families while transitioning to a new model of doing business that embraces the changes in healthcare delivery and technologies. We have all heard that traditional inpatient stays across all of healthcare continues to diminish while more and more healthcare services have shifted to outpatient care. Understanding the industry as a whole has seen this shift in care and seeing it first hand in the volumes and activities at our hospital the consultants and workgroup discussed what the best option would be for SCH-Twin Cities.

A few days prior to Imperial Sir Gantts message, the consultants, along with local Board of Governors and hospital leadership met with the Joint Boards to review the consultant recommendations. A broad variety of options had been discussed and vetted during this process. For SHC-Twin Cities it was determined that we shift to a new Shrine Clinic operating model, shift inpatient and outpatient surgical procedures to a partner healthcare group and expand our presence in our catchment area. As a bit more detail, following are plans as we know them today, based on the consultant recommendations approved by the Joint Boards.

#### **Transition of Inpatient/Outpatient Surgical Procedures**

It was recommended that due to the low volume of surgical procedures occurring at SHC-Twin Cities (currently about 400 total) it would best serve our patients to move that part of care to a partner location. Our doctors would still be doing the procedure but would be doing so at the partner facility. We continue to have discussions with multiple groups regarding a partner relationship and we hope to have a final decision in the coming weeks. This type of transition has a broad list of activities that need to happen including license changes, contract changes, new contracts... so this is not something that can just happen in a few weeks. The approved

recommendations of the consultants showed this transition happening over the course of 5 or 6 months.

#### Sighting and transition to a Clinic facility

With the move of surgical procedures, SHC-Twin Cities would begin operating as a clinic and rehab facility, continuing our outpatient clinic activities just as we do today. There is not a current plan for this transition, decisions regarding the leasing of space, buying space... will likely start in a few weeks but there are many elements to this transition similar to those noted in the previous paragraph. Until the time a location is chosen and developed we will continue to operate in our current facility. Your local Board of Governors has made it clear that the expectation of a clinic will be a facility that continues the "Shrine Experience" for our patients and their families, delivering the services and treatment our kids have come to know as Shriners.

#### **Outreach Expansion**

We have all heard, "More Kids, In More Places, More Cost Effectively". SHC-Twin Cities has a long history of supporting Outreach Clinics throughout our catchment area. The workgroup and consultant recommendations call for the expansion of these effort with development of broader relationships throughout our service area. Two areas targeted for an initial expanded effort are Des Moines and Omaha, both of which we have existing relationships we hope to leverage to broader relationships. We will continue outreach clinic activities as we have previously done and as we move forward we will look to expand services in the existing areas as well as looking to new outreach opportunities.

We all know that change is a difficult thing and with this transition there will be hard decisions to be made and major change to prepare for. Your local Board of Governors is unanimous in our desire and intent to make this transition as smooth as possible for our patients, their families, our wonderful employees and the nobility that supports us.

As before, we will need your help and support as these changes unfold. We commit to communicating information to you as we garner it so that you can share with your Temples. We truly appreciate your support and will do all we can to grow the efforts of helping our kids through the greatest philanthropy in the world.

On behalf of the SHC-TWI Board of Governors, we thank you and your nobility for your support!
