

Shriners Hospitals for Children

First in Chicago to offer new lightweight prosthetic partial hand for teenagers

Pediatric Orthotic and Prosthetic Services (POPS) – Midwest, LLC, at the Chicago Shriners Hospital is now offering a new lighter-weight hand prosthetic for children ages 12 and above. M-Fingers has been available for adults, but they now offer a pediatric version of the artificial partial hand. Shriners Hospitals is the first hospital in Chicago to offer this carbon fiber technology that is specifically designed to fit children.

Often children who are missing some or all of their fingers may choose not to get an artificial hand because the devices can be heavy or uncomfortable to wear. Existing lighter-weight versions may be cosmetic in nature and not functional. The pediatric M-Fingers device is custom-made for each patient using lightweight carbon fiber. The "fingers" are activated through a patient's wrist movement. Patients are also allowed to customize the color scheme of their M-fingers. The two patients who have received M-fingers so far said it is "very cool." Both were not previously wearing a prosthetic but desired to have more hand functionality to pursue hobbies and everyday activities they enjoy. Nationally, less than 20 children have received a pediatric M-fingers device so far.

POPS – Midwest, LLC, at Shriners Hospitals for Children — Chicago is an in-house service, providing care for our patients who need prosthetic and orthotic devices. From infancy to 18 years of age, the experienced and certified POPS staff provides upper and lower orthotic and prosthetic services. The staff also provides spinal orthotic services for a wide spectrum of orthopaedic conditions such as congenital and acquired deformities including scoliosis and those caused by disease, infection, sports injuries, and trauma.

The orthopaedic care at the Chicago Shriners Hospital of M-fingers patients and other patients with limb differences is overseen by attending physician Jeffrey Ackman, M.D., a pediatric orthopaedic surgeon, who manages the largest clinic in the Chicagoland area for children with limb differences, amputations, prosthetics, and orthotics. Onsite occupational therapy for M-finger patients may also be available.

Shriners Hospitals for Children is serving more kids in more places and providing the most amazing care anywhere. If you know of a child who could benefit from our services, ask the family to call SHC-Chicago at (773) 385-KIDS (5437), or call the national number, (800) 237-5055.

Shriners Healthcare for Children TWIN CITIES

As we jump into 2021, let us remember and recall the highlights of the 2020 as it relates to our Shriners Children's – Twin Cities. The year 2020 saw a great deal of change and transition in Twin Cities. This is true for the last couple of years and we should expect change to be a mantra for each year to come. Healthcare is changing each day: regulation, billing/revenue, technology, scope of practice, service setting, etc. Shriners Children's Twin Cities ("SCTC") started on the path to change with the rest of healthcare almost three years ago. We can expect continued change to assure we secure and advance our mission to treat kids. The Board of Governors ("BOG"), SCTS Leadership, and SCTS staff and Our Nobility should take pride in what it has accomplished over the last several years.

Some of the key highlights of 2020 are broken into subcategories below -

- Strategy
- ★ Woodbury Relocation 215 Radio Drive, Suite 100 | Woodbury, MN 55125
- We opened for business at new location on June 29, 2020
- Previous site sold to University of Minnesota and closed on July 31, 2020 for a purchase price of approximately \$22.5M
- ★ Blank Children's Initiated a new model of care in Des Moines, IA in affiliation with UnityPoint Health System.
- Adds a new location to the Shriners' portfolio while bringing a quality pediatric orthopaedic service line to a community in need.
- Shriners' is the exclusive physician providers of Blank Children's clinic.
- Temple and Women's Auxiliary support through volunteer efforts and transportation/hospital funds can be used to support patients seeking pediatric orthopaedic services from our physicians at this location
- ★ Shriners Children's Twin Cities We have rebranded to this name to reflect the trends in healthcare industry; Twin Cities is one of a few sites having already transitioned in naming convention, taking advantage of our relocation.
- Operations
- ★ Transition of Leadership
- Charlie Lobeck after fifteen years of leadership to our mission, Charlie retired on September 18, 2020
- Terri Kasbohm Director of Patient Care Services, after almost thirty years of service and leadership to our mission, Terri retired on November 25, 2020
- Roger Robinson after three years as Chairman of the Twin Cities BOG, Roger was honored in transition to an Emeritus member
- ★ Outreach and Regional Service (More Kids, More Places, at Less Cost)

- COVID-19 caused a year-long pause on outreach clinics at each of our three main outreach clinics (Omaha, NE, Rapid City, SD, Bismark, ND) and out-of-town screening clinics
- Radiology agreements were finalized with our host organizations in each of the three main outreach clinic locations, allowing patients to obtain radiographs for prior to telehealth visits (and future onsite clinics)
- Exploring alternative means to treat kids in outreach locations
- Boys Town single patient agreement Pilot developing agreement to pilot Boys Town physician performing surgery on a Shriner patient in first part of 2021
- Outreach travel will not commence until after all staff are vaccinated
- Finance & Volume –COVID-19 continues to significantly impact volume and all related indicators; Twin Cities will end the year favorable to budget secondary to the overall reduction of expenses associated with the reduction of volume; November Year-To-Date 2019-2020 comparative (system change in parenthesis following SCTC, if applicable) -
- ★ Operating Expenses (YTD \$6.3M): 14% reduction
- ★ Outpatient Encounters (YTD 3,480): 32% reduction (24% reduction)
- ★ Telehealth Encounters (YTD 382): 961% increase (925% increase)
- ★ Donation Revenue (YTD \$1.67M): 42% reduction (39% increase)
- ★ Draw on Endowment (YTD \$1.98M): 48% reduction (3% reduction)
- COVID-19 Vaccine update
- ★ State of MN has sub-prioritized Phase 1a (includes all healthcare facility personnel) into three priorities (First, Second, Third)
- ★ State of MN is currently finishing First Priority and entering Second Priority
- o All STCS staff, except Providers going to Hospital, fall into Third Priority
- Providers going to Hospital fall into Second Priority and are scheduled to receive vaccination starting week of January 11
- ★ Remaining STCS staff will obtain through either Gillette Children's or Washington County Public Health, dependent upon which is faster in rollout to Third Priority; timeline to enter Third Priority is estimated for the beginning to mid-February

BEJA 10 TEAM CORN HOLE LEAGUE RULES

THE GAME

Play alternates between players on a side until they've tossed all bags. Players may only throw one bag at a time and must stay behind the front edge of the board. Scoring is assessed at the end of the frame based on cancellation where opposing teams will cancel their points (net scoring): The first team to score 21 points wins the game. Boards will be placed 27 feet (front to front) from each other. This distance is paced out by the league manager. Cornhole boards and bags will be provided. Each lane consists of 2 boards and 8 bags.

BEGINNING OF THE GAME

Begin the game with a coin flip between the two captains. The winner determines one of two options: which side of the board their team will throw on or first throw. The losing team will get this choice to start the second game. If the match reaches a third game, another coin flip is played to determine side/shooting preference. In the playoffs, the higher seeded team will have this option in game one. Each team must stand on the same side of the board.

POSITION OF PLAYERS DURING PITCHING

- 1. The pitcher must be within the pitcher's box or behind the foul line at the time of release.
- 2. A player must pitch all four bags from their designatedpitcher's box.
- 3. Players must pitch the bag with an underhand release.

PLAY OF THE GAME

Every match is broken down into innings of play. During an inning of play, each player must pitch all four of his/her bags. An inning is never completed until all players pitch all four of his/her bags.

- 1. Each team will stay in their designated lane for the whole game.
- 2. Players at the headboard will alternate pitching bags until each player has pitched all four of his/her bags.
- 3. Players at the footboard will take score and resume pitching back to the other board.
- 4. The top of an inning is completed when both players pitching from the headboard pitch all four bags; the bottom of the inning is completed when the remaining players pitching from the footboard pitch all four bags.

VALUE OF THE BAG

The approved method of scoring for the sport of cornhole is "cancellation" scoring. In cancellation scoring, the points of one player cancel out the points of their opponent. Using this method, only one player/team can score in each inning.

Bag In-The-Count (Woody): Any bag which comes to rest anywhere on top of the board. Each is worth one (1) point.

Bag In-The-Hole (Cornhole): Any bag which is thrown through the hole or knocked through the hole by another bag. Each is worth three (3) points.

Foul Bags – Refers to any bag that has not been determined as Bag In-The-Count or Bag In-The Hole or was designated a foul bag as the result of rules violation.

PITCHING ROTATION DURING THE GAME

The player or team who scored in the preceding inning has honor pitching first in the next inning. If neither player or team scores, the player or team who pitched first in the preceding frame shall retain first pitch in the next frame.

FOUL BAGS

1. The following are rule violations that must be spotted and called by a player or assigned judge. The penalty is to declare the bag a foul bag, which requires the bags to be removed from the court prior to resuming play.

A foul bag is defined as:

- (a) Any bag pitched when the player has (1) made contact with or crossed over the foul line, or (2) started or stepped completely outside the pitcher's box before the bag is released
- (b) Any bag not delivered within the 20second time limit
- (c) A bag pitched from a different pitcher's box than the first bag
- (d) Any bag that contacted the court or the ground before coming to rest on the board
- (e) Any bag that struck a previously defined object such as a tree limb, wire, indoor court ceiling, etc.
- (f) Any bag on the board that is also touching the ground
- (g) Any bag removed from the board before scoring has been agreed upon for that bag
- i. The offending team (who touches the bags) forfeits all remaining bags and tallies the score of just the bags thrown before the foul was reported.
- ii. The non-offending team tallies twelve (12) points as if they had thrown four Bag In-The-Holes (Cornholes) during the inning.
- 2. A bag that leaves a player's hand once the final forward swing of the delivery process has started shall count as a pitched bag.
- 3. A bag that is accidentally dropped by a player before the final forward swing has started shall not be considered foul and may be picked up and pitched.
- 4. A bag hanging off the edge of the board has value unless it is touching the ground.

Protest –If a player desires to make a protest, the protest shall be made to the judge or official at the time the problem occurs. The judge shall make the final ruling on all protests.

TEAM SIZE

A minimum of 2 players per team must be present to play each week. While 2 players are the minimum you may have as many players on your team as you choose. You can always sub people in each night too! Substitutions can happen after a frame. If a player arrives during play, they may only join their team after a frame.

LENGTH OF GAMES

A regulation match lasts 40 minutes from the designated start time or until one team reaches 21 points in each game. Games are played first to 21 points; a team does not need to win by 2 or more points. A team does not need to score exactly 21 points and can go over 21. Each match will be played to the best out of three games against your scheduled opponent.

PLAYOFFS

The playoffs will take place in the 10th and final week. The number of teams competing in the playoffs will be determined by the total number of teams in the league and will consist of a single elimination tournament. No substitutes will be allowed during playoffs and all players must have already played in at least one regular season game and be on the team roster.

PLAYER ELIGIBILITY

Players on the roster are eligible for the regular season and playoffs. Any player protests in the playoffs must be done before a game.

FORFEIT POLICY

If your team forfeits a game during the season, the following rules apply:

First Offense: Loss of game. Score marked: 2-0.

Second Offense: Loss of game and lost ability to make playoffs.

Third Offense: Removal from the league.

If you know in advance that your team is going to forfeit a game, we encourage you contact us so we can inform your opponent. Since each team will play 2 games a night if you end up missing one week you are immediately ineligible for playoffs so please do your best to have enough players to avoid any forfeits.

Teams have until five minutes past the designated start time to field a full squad (or the league minimum of players required according to rules). If at that time a team is unable to field a legal team, they forfeit the game. The teams may utilize the playing field during their allotted time to play an unofficial game. The official score will be marked as a loss with the respective forfeit score.

In 2009, several Freemasons from New South Wales, Australia, had an interest in becoming Shriners. They ultimately became members of Aahmes Shriners in Livermore, California, and started the Sydney Shrine Club (since disbanded). In 2010, a group of Freemasons from Melbourne visited them, took an interest and subsequently became Shriners, forming the Melbourne Shrine Club (MSC). Despite the challenges faced by the pandemic, the club is still thriving today with 84 members and big plans for the future.

Noble Peter Atkin, Secretary, shared the Club's five-year strategy to increase membership, form regional clubs and improve member retention. One goal is to actively promote Shrine tenets through participation in community events like festivals, parades, and horticultural and agricultural shows. They are developing a program to train select Nobles on how to best represent the Club at events, and are equipping them with displays and promotional materials. 
