### News from Shriners Hospital Chicago

**Shriners Hospitals for Children** 

While we confront the COVID virus and the recent protests we are ramping up the services here in Chicago. Illinois eased restrictions on May 29 followed by Chicago on June 3. It is a long way from normal or having everything open but these are positive steps in getting back to the business of caring for kids.

Nurse Executive Terri Aiello, Chief of Staff Purnendu Gupta, and Administrator Mark Niederprumn have been in constant communication throughout this ordeal. Starting the week of March 16 a daily incident command was established. Weekly town hall meetings have been held with the participation of 200+. Clinical activity was slowed to only urgent cases and the vast majority of staff stayed at home from mid-March to early May. Staff was required to take time off during this extended period. The Joint Boards approved the reinstatement of time off related to the COVID situation from mid-March through the first of May. This was a generous act and one that was greatly appreciated by all staff.

Beginning the week of May 11 the state of Illinois allowed elective surgery to begin. Since that time, the pace of activity has increased and as an example this week 21 surgeries were scheduled and all three operating rooms were open. We are not at full capacity; however, this signifies a big step in getting back on track. A big part of this ramping-up has been the use of telehealth. Although this tool has been around for several years, the COVID situation has caused its use to increase exponentially. The capability of reaching a patient in their home with a smartphone, iPad, or computer has completely changed the use of this technology. Ease of regulations has helped this effort and it is hoped these regulations will become permanent. New workflows and some added steps and personnel have been needed to improve the patient experience and the provider's efficiencies. Telehealth is here to stay so we are tasked with making this part of our new normal.

Personal protective equipment (PPE) is a key element in moving forward until a vaccine or treatment becomes available, this will be an on-going need. Supplies are slowly catching up with demand and through the vigilant efforts of our supply chain staff, SHC Chicago is adequately supplied for clinical and surgical activity. Continued vigilance is needed to extend the life of the supplies on-hand as well as reuse of supplies where appropriate. Again, this will be the new normal for the foreseeable future and this comes at a financial cost to the organization. Projections for these additional costs will be forecast for the second half of 2020 and will be incorporated into the 2021 budget process. A reminder that all who enter the facility are required to wear a mask.

COVID testing is another key element in providing a safe environment for all. SHC Chicago was fortunate to have the

analyzer in-house before the COVID situation for another point of care testing. Presently, two tests per hour can be performed. The analyzer can accommodate two additional modules and these have been ordered but not yet received. When they are in place, four tests per hour can be performed. Currently, all surgery patients and patients admitted to the inpatient unit are being tested. If the test is positive the surgery or admission is postponed.

The decision to permit volunteers, students, visitors, or others in the building are being discussed. The fewer people in the building reduces the risk of exposure and decrease the use of PPE. This will be an ongoing dialogue throughout this ordeal.

While we get the patient care process reinstated, the focus on long range planning continues. We are in the process of selecting a consultant with input from the University of Illinois and Shrine headquarters. Once initiated the engagement is projected to last approximately 90 days therefore findings will likely be available in the October/November time frame.

Our great Fraternity has seen many changes in our nearly 150-year history, from world wars to the rise of industry and technology. The recent announcement of our new brand, Shriners Children's™, is a step toward unifying all of our locations, regardless of the means of providing care, under one brand. This is not a name change, but a change in our brand strategy to meet the constantly evolving world of health care.

From a fraternal perspective, the branding is going from four words to two words, and the branding simply focuses on who is providing care and who is being served. For nearly 100 years, our mission has been to work consistently to build a health care brand synonymous with outstanding medial expertise and the most amazing care anywhere. Due to this reputation, we are able to shorten our brand, something consumers prefer in today's digital age.

There has also been some concern raised over how the name will function with its possessive ending. The brand will be used as a master brand with a more specific label following. For example one of our research initiatives in Genomics, could become Shriners Children's Genomic Institute.
