10 Teams minimum needed to play a 9 week league

League will be starting in late 2020 on the 2nd and 4th Mondays of the month, doors open at 6:00pm, League starts at 6:30pm.

Two person teams can be husband and wife or two Nobles. The winning team will win transportation and hotel expenses paid to the 2021 Imperial Session and compete in the Imperial 2021 Cornhole Tournament. The cost is \$100 per team and we will provide snacks and have our cash bar open during League Play.

BEJA 10 TEAM CORN HOLE LEAGUE RULES

THE GAME

Play alternates between players on a side until they've tossed all bags. Players may only throw one bag at a time and must stay behind the front edge of the board. Scoring is assessed at the end of the frame based on cancellation where opposing teams will cancel their points (net scoring): The first team to score 21 points wins the game. Boards will be placed 27 feet (front to front) from each other. This distance is paced out by the league manager. Cornhole boards and bags will be provided. Each lane consists of 2 boards and 8 bags.

BEGINNING OF THE GAME

Begin the game with a coin flip between the two captains. The winner determines one of two options: which side of the board their team will throw on or first throw. The losing team will get this choice to start the second game. If the match reaches a third game, another coin flip is played to determine side/shooting preference. In the playoffs, the higher seeded team will have this option in game one. Each team must stand on the same side of the board.

POSITION OF PLAYERS DURING PITCHING

1. The pitcher must be within the pitcher's box or behind the foul line at the time of release.

2. A player must pitch all four bags from their designated pitcher's box.

3. Players must pitch the bag with an underhand release.

PLAY OF THE GAME

Every match is broken down into innings of play. During an inning of play, each player must pitch all four of his/her bags. An inning is never completed until all players pitch all four of his/her bags.

1. Each team will stay in their designated lane for the whole game.

2. Players at the headboard will alternate pitching bags until each player has pitched all four of his/her bags.

3. Players at the footboard will take score and resume pitching back to the other board.

4. The top of an inning is completed when both players pitching from the headboard pitch all four bags; the bottom of the inning is completed when the remaining players pitching from the footboard pitch all four bags.

VALUE OF THE BAG

The approved method of scoring for the sport of cornhole is "cancellation" scoring. In cancellation scoring, the points of one player cancel out the points of their opponent. Using this method, only one player/team can score in each inning.

Bag In-The-Count (Woody) : Any bag which comes to rest anywhere on top of the board. Each is worth one (1) point.

Bag In-The-Hole (Cornhole) : Any bag which is thrown through the hole or knocked through the hole by another bag. Each is worth three (3) points.

Foul Bags – Refers to any bag that has not been determined as Bag In-The-Count or Bag In-The Hole or was designated a foul bag as the result of rules violation.

PITCHING ROTATION DURING THE GAME

The player or team who scored in the preceding inning has honor pitching first in the next inning. If neither player or team scores, the player or team who pitched first in the preceding frame shall retain first pitch in the next frame.

FOUL BAGS

1. The following are rule violations that must be spotted and called by a player or assigned judge. The penalty is to declare the bag a foul bag, which requires the bags to be removed from the court prior to resuming play.

A foul bag is defined as:

(a) Any bag pitched when the player has (1) made contact with or crossed over the foul line, or (2) started or stepped completely outside the pitcher's box before the bag is released

(b) Any bag not delivered within the 20-second time limit

(c) A bag pitched from a different pitcher's box than the first bag

(d) Any bag that contacted the court or the ground before coming to rest on the board

(e) Any bag that struck a previously defined object such as a tree limb, wire, indoor court ceiling, etc.

(f) Any bag on the board that is also touching the ground

(g) Any bag removed from the board before scoring has been agreed upon for that bag

i. The offending team (who touches the bags) forfeits all remaining bags and tallies the score of just the bags thrown before the foul was reported.

ii. The non-offending team tallies twelve (12) points as if they had thrown four Bag In-The-Holes (Cornholes) during the inning.

2. A bag that leaves a player's hand once the final forward swing of the delivery process has started shall count as a pitched bag.

3. A bag that is accidentally dropped by a player before the final forward swing has started shall not be considered foul and may be picked up and pitched.

4. A bag hanging off the edge of the board has value unless it is touching the ground.

Protest –If a player desires to make a protest, the protest shall be made to the judge or official at the time the problem occurs. The judge shall make the final ruling on all protests.

TEAM SIZE

A minimum of 2 players per team must be present to play each week. While 2 players are the minimum you may have as many players on your team as you choose. You can always sub people in each night too! Substitutions can happen after a frame. If a player arrives during play, they may only join their team after a frame.

LENGTH OF GAMES

A regulation match lasts 40 minutes from the designated start time or until one team reaches 21 points in each game. Games are played first to 21 points; a team does not need to win by 2 or more points. A team does not need to score exactly 21 points and can go over 21. Each match will be played to the best out of three games against your scheduled opponent.

PLAYOFFS

The playoffs will take place in the 10th and final week. The number of teams competing in the playoffs will be determined by the total number of teams in the league and will consist of a single elimination tournament. No substitutes will be allowed during playoffs and all players must have already played in at least one regular season game and be on the team roster.

PLAYER ELIGIBILITY

Players on the roster are eligible for the regular season and playoffs. Any player protests in the playoffs must be done before a game.

FORFEIT POLICY

If your team forfeits a game during the season, the following rules apply:

First Offense: Loss of game. Score marked: 2-0.

Second Offense: Loss of game and lost ability to make playoffs.

Third Offense: Removal from the league.

If you know in advance that your team is going to forfeit a game, we encourage you contact us so we can inform your opponent. Since each team will play 2 games a night if you end up missing one week you are immediately ineligible for playoffs so please do your best to have enough players to avoid any forfeits.

Teams have until five minutes past the designated start time to field a full squad (or the league minimum of players required according to rules). If at that time a team is unable to field a legal team, they forfeit the game. The teams may utilize the playing field during their allotted time to play an unofficial game. The official score will be marked as a loss with the respective forfeit score.

This has not been a good membership year for Beja. COVID-19 has caused the postponement of the Fall Ceremonial and our recruitment efforts have been extremely hampered. The financial impact has found that many have not been able to pay their membership dues, and we are on track to lose several members this year.

The Spring Ceremonial only yielded one creation and the Black Camel has already claimed eleven Nobles with three months left in the year.

Imperial Potentate Jim Smith has continued the 'Just One' program for 2020-2021. The sound theory behind the campaign is that if each Shriner will commit to signing "Just One" recruit or restoration, the fraternity will experience tremendous growth. Help rebuild our Fraternity to the stature it once had. Beja Shriners started out in 1986 with over 1,000 members. Today we have less than 400. Everyone benefits from the program, Beja, Shriners International, and our philanthropy, Shriners Hospitals for Children will benefit. Do your part to grow Beja and the fraternity.

So, start now to recruit for the Spring Ceremonial. Will you find that 'Just One'? The fee for a candidate joining in the Spring Ceremonial is \$149. That includes the initiation fee, 2021 dues, and the hospital and per capita assessments (a fez is not included but can be ordered [approximately \$200] or a used fez may be available for purchase).

Nobles who have not yet paid their 2021 dues, or are in arrears for 2020 or past years, should have received a hardcopy dues notices in the mail. You may remit your dues in one of three ways, mail, phone, or online. If you call the office to pay over the phone a \$3 convenience fee will apply. You may pay online at <u>webfez.shrinenet.org</u>. If you have a balance, a 'Pay Your Bill' button appears on your page. You may safely follow that link to remit your dues. This service has been approved by Shriners International and immediately updates your Shrine record. Remember, dues are payable <u>PRIOR</u> to December 31st.


